

Experience

Breach of Commercial Real Estate Lease

Defending client in tenant lawsuit alleging breach of a commercial real estate lease involving properties in Utah, Oregon and California.

Dwayne Johnson et al. v. Highlands Water Company (2021 Morgan County, Utah)

Water contract dispute successfully argued at the trial court and settled in mediation.

Estate of Edith T. Roberson (Unpublished September 26, 2019 Order of Affirmance, Utah Court of Appeals)

This was a probate dispute between siblings over inheritance rights under the decedent's Will and Trust. The decedent was a Utah artist. The dispute was successfully argued at trial, in the Utah Court of Appeals and at the Utah Supreme Court.

B.A. Wackerli Company, Inc. et al v. Wareing Corporation et al. (2019 Idaho State Court)

Contract dispute over ownership of four car dealerships located in Idaho Falls and Twin Falls, Idaho. Successful result in the trial court and mediation.

George Robertson v. Houweling's Nurseries Oxnard, Inc. (2017 Utah Federal Court)

Contract dispute over ownership of a commercial hydroponic tomato plant greenhouse in Mona, Utah. Summary judgment granted in favor of Houweling's Nurseries.

Iota, LLC v. Davco Management Company, 2016 UT App. 231

This case involved issues with real property, foreclosure, a deficiency judgment, contempt of court and application of the collateral bar doctrine.

Van Denburgh v. Sweeney Land Company in Park City II, LLC, 2013 UT App. 265

This case involved whether an easement existed over development property in Park City.

Machock v. Fink, 137 P.3d 779 (2006)

This dispute over application of the Utah One Action Rule, foreclosure under the Utah Trust Deed Act and application of an unconditional guaranty agreement was successfully argued before the Utah Court of Appeals and the Utah Supreme Court. This opinion is still the leading case in Utah on guaranty agreements.

Cook Associates, Inc. v. PCS Sales (USA), Inc., 271 F.Supp.2d 1343 (D. Utah 2003)

Successful defense for claims of defective materials. This is the first case in Utah applying the tort of spoliation of evidence.

Bear River Water Conservancy District and Utah and Salt Lake County Canal Company

Several state court lawsuits for both water companies over water rights and prescriptive easements.
