Board of Podiatry initiated after a patient complaint. The Idaho Division of Occupational and Professional Licenses Board ultimately determined there was insufficient evidence to pursue the action further and the patient complaint was closed.

Obtained favorable Agreement in Lieu of Disciplinary Action for physician being investigated by the Idaho State Board of Medicine.

Healthcare

Assisted hospice client in self-disclosing employment of an excluded individual to the Office of Inspector General, which self-disclosure included estimate of damages favorable to client. Ultimately worked to a settlement agreement with OIG that was favorable to client.

Employment

Successfully defended hotel employer against a national origin discrimination and retaliation charge filed by former employee with the Idaho Human Rights Commission (“IHRC”). After responding to the charge, the IHRC found no probable cause that unlawful discrimination or retaliation occurred and the charge was dismissed. No further lawsuit was pursued by former employee.

Successfully defended employer against a national origin discrimination charge filed by former employee with the IHRC. After responding to the charge, the IHRC found no probable cause to believe that unlawful discrimination occurred. No further lawsuit was pursued by former employee.

Business and Commercial Litigation

Defended against claims pursued by private and public property owners resulting from a forest fire that started on client’s logging operation. Ultimately obtained a favorable settlement agreement within policy limits at mediation despite extensive damages sought by private and public property owners.

Obtained a favorable summary judgment ruling that dismissed all claims pursued against client relating to sale of real property.

Assisted trial team in successful defense and counterclaim of a breach of contract dispute arising from a subcontract agreement. After a five-day jury trial, the jury returned a verdict in favor of our client finding that our client did not breach the subcontract agreement, that the subcontractor did breach the subcontract agreement, and, as a result, our client was entitled to damages. After judgment was entered in favor of our client, we were awarded nearly all attorneys’ fees and costs sought from the court.

Successfully defended client in obtaining a favorable summary judgment that resulted in complete dismissal of the breach of contract claim pursued against client.

Medical Malpractice Settlement

A medical malpractice lawsuit was brought against our client, a podiatrist in Twin Falls, Idaho. In the course of litigation, it was determined that plaintiff’s expert witness disclosures were deficient under Idaho law. We prepared materials to summarily dismiss plaintiff’s medical malpractice claims because plaintiff could not establish his case through direct expert testimony. Rather than facing our summary judgment motion, plaintiff agreed to dismiss his lawsuit with prejudice.
