### **Ocampo v. Corizon L.L.C., No. 20-35990, 2022 WL 229093 (9th Cir. 2022)**

Secured unanimous decision affirming summary judgment decision dismissing plaintiff’s Eighth Amendment deliberate indifference claims.

Represented collection agency in attorney fee appeal that threatened to create precedent jeopardizing the company’s business interests in other cases, and successfully avoided adverse legal precedent on core statutory interpretation issue, even though the client was unsuccessful in securing attorney fees in the instant case.

**Franklin v. Franklin, No. 47219, 2019 WL 6248014 (Idaho Ct. App. Nov. 22, 2019)**

Represented mother in challenge to order divesting mother of shared custody based solely on her temporary employment status during the divorce.
